## **Ameren Improves 2013 Corporate Social Responsibility Report** *Improved report now on par with industry peers*

**Tues, Mar. 25** – After engagement with environmental nonprofits As You Sow and the Midwest Coalition for Responsible Investment (MCR), the St. Louis-based utility Ameren Corporation has released its 2013 Corporate Social Responsibility (CSR) report. The new report represents an improvement over its prior disclosure, and brings the report up to the industry standard. The changes came about following a dialogue stemming from a 2013 shareholder resolution filed by As You Sow and MCR requesting increased transparency on water impacts.

“Ameren’s 2013 CSR report shows improvement over previous years. It touches on more topics, and offers more data,” said Amelia Timbers, Energy program manager at [As You Sow](http://AsYouSow.org). “Shareholders and Investment managers require detailed CSR reporting to evaluate business risk. Ameren’s CSR reporting improvements are a step in the right direction.”

Sister Barbara Jennings of the [Midwest Coalition for Responsible Investment](http://MidwestCoalitionforResponsibleInvestment.org) said “The twenty faith-based members of MCR urge investors and ratepayers to review the Ameren website to learn more about the improvements in environmental transparency. Ameren recognizes that the company must move forward responsibly to both greater disclosure and sustainability; clean water is essential to human life and to biodiversity.”

Among the improvements Ameren has made:

- 2013 CSR report includes a wider range of topics than prior versions;
- 2013 CSR report provides plant-level environmental data, including disclosure of each coal-fired plant’s emissions;
- In addition to its CSR report, Ameren now also completes the carbon portion of the annual environmental survey issued by the Carbon Disclosure Project;
- Ameren has adopted an internal water policy which will consider the impacts of its operations on water.

In addition to requesting goals to reduce water risk, As You Sow has previously filed shareholder resolutions with Ameren asking for a plan to reduce exposure to the costs and risks associated with continued reliance on coal. In light of the improvement in its CSR report, As You Sow and MCR decided not to refile in 2014, and instead are recognizing Ameren’s positive actions.
